The Foundation also supports early childhood education, parent education, violence prevention, mentoring and tutoring, and the summer learning "Get Ahead Program" for middle school students. The Foundation has provided the campaign leadership for several ballot initiatives that have brought \$18 million for classroom enrichment and \$110 million for infrastructure improvements.
